What are cookies?

Cookies (also known as tags) are text files with small pieces of data used to identify your devices whenever you browse a computer network. This data is labelled with an ID unique to you which becomes linked to the device you use to access our services, and enables us to recognise you and store information about your activity on our website and mobile app. We use cookies and similar technologies like single-pixel gifs and web beacons. They are both session-based and persistent cookies. We set and access our own cookies on the domains operated by Paysend and its corporate affiliates (collectively, the "Sites").

Types of cookies we use and why

The cookies we use serve different purposes and are divided as follows:

Strictly Necessary Cookies. We use these cookies to provide you with our services, ensuring the functionality of our website and mobile app, as well as enabling us to provide our services to you safely and securely. Without them we would be unable to provide our services to you, which means that they cannot be switched off. If you block these cookies, you may not be able to properly access our services.

Customer Experience Cookies. We use these cookies to customise your experience. They are associated with your account and personal information in order to remember that you are logged in, login credentials, your privacy preferences, and other requests for services that you make. They give you a personalised experience that's consistent with your settings. They also make your interactions faster and more secure. You can opt in or opt out on usage of these cookies whenever you like.

Performance Assessment Cookies. We use these cookies to obtain aggregated auditing, research, and reporting, and know when content has been shown to you. They also help us improve our performance by measuring visits and traffic sources, find and fix issues, and check your interaction with our products. Information collected in this manner is fully aggregated and therefore anonymous. Your non-acceptance means we cannot monitor our performance in respect to your experience. You can opt in or opt out on usage of these cookies whenever you like.

Advertising Cookies. We use third party cookies and other ad technology such as beacons, pixels, and tags to help us market more effectively to you and to consumers that we and our partners believe may be interested in Paysend.
